The foundation is registered with SARS which has reciprocal agreements with the Internal Revenue Service (IRS) in the USA and HM Revenue and Customs (UK). We are able to issue 18A Certificates to donors, enabling them to claim an income tax deduction for a donation made. (In South Africa, up to a limit of 10% of taxable income). Ingwe's accounts are subject to audit

We launch the Ingwe Education Foundation at a pivotal moment in the life of our school. As you may be aware, and as the launch presentation will illustrate, our 65-year old school is in process of renewal and development.

Funds will not be directed towards the operating expenses of the school.

Its founding directors were approved by the School Governing Body and are:




